

Board of Selectmen
Unapproved Minutes
Tuesday, February 20, 2020

On Tuesday, February 20, 2020 at 6:00 p.m., the Board of Selectmen met in Meeting Room A, the Municipal Building, 10 Grandview Road, Bow, NH. 03304.

I. CALL TO ORDER

At 6:00 p.m. Chairman Nicolopoulos called the Board of Selectmen meeting to order.
Present: Chairman Christopher Nicolopoulos, Vice Chair Colleen Hunter, Selectman Harry Judd, Selectman Matthew Poulin, Selectman Michael Wayne, Town Manager David Stack, Administrative Assistant Tonia Lindquist and members of the public.

II. PUBLIC HEARING

Chairman Nicolopoulos opened the Public Hearing for comment at 6:00 p.m. and gave a brief overview of the reason for the Public Hearing.

With no comments from the public Chairman Nicolopoulos closed the public hearing at 6:02 p.m.

Dan Weed, 21 Birchdale Road, Bow Pioneers Snowmobile Club, Mr. Weed explained to the Board the gate would be located right at the water crossing or tree line, so it would not affect any access. The Bow Pioneers will manage the gate and work with the Town on an Agreement with the Bow Pioneers Snowmobile Club.

A MOTION was made by Selectman Poulin and duly seconded by Selectman Wayne to bring forward the warrant article re-classifying Farrington Corner Road as a Class A Recreational Trail to town meeting. MOTION PASSED 5-0.

Selectman Judd thanked the Bow Pioneer Snowmobile Club for all they do for the Town.

III. DISCUSSION/ACTION ITEMS

Selectman Judd discussed with the Board a request on behalf of the Scouts. A Senior Scout would like to hold an ice fishing training day at the Town Pond as part of his senior project.

A MOTION was made by Selectman Judd and duly seconded by Selectman Wayne to authorize the use of the Town Pond by the Scouts for a day training on ice fishing, and to have the scouts coordinate the specifics with Public Works Director Tim Sweeney. MOTION PASSED 5-0.

At 6:09 p.m. A MOTION was made by Selectman Judd and duly seconded by Selectman Poulin to enter into non-public session. MOTION PASSED 5-0.
